

**TERMS AND CONDITIONS FOR
WIN-YOUR-CHRISTMAS-WISH-AT MILLER CENTRAL COMPETITION**

1. Participation in this Promotion and information regarding redemption of any Gifts forms part of these terms and conditions. Participation In this WIN-YOUR-CHRISTMAS-WISH-AT MILLER CENTRAL COMPETITION (“Promotion”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in AEST local daylight savings time.
2. Subject to condition 3, this Promotion is only open to **NSW** residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all terms and conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
3. The following are ineligible:
 - (i) employees of the Promoter (JEA HOLDINGS (AUST)PTY LTD AFT THE MILLER INVESTMENT TRUST TRADING AS MILLER CENTRAL), the Tenants or Tenant’s employees or any of the Promoter’s agencies that are associated with the Promotion;
 - (ii) the spouse, defacto, spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.
4. This Promotion commences at 10am on Friday 26 November - and ends at 4pm on Friday 17 December 2021 (“Promotional Period”).
5. To enter, participants must during the Promotional Period:
 - (a) Spend \$20 or more in one transaction at any Miller Central specialty store OR \$100 or more in one transaction at Woolworths or Aldi at Miller Central during the Promotion Period excluding any Ineligible Transaction. (“Qualifying Spend”).
 - (b) Request and complete an entry form from the retailer, attach a valid receipt to the entry form (or if you need to retain your receipt, you must be able to present your valid receipt if you are a winner) and place in the entry barrel located at Miller Café near the Food Court.
 - (c) Customers may enter as many times as they would like but only once per valid receipt. Each entry must be submitted separately and in accordance with the entry requirements. An “Ineligible Transaction” means any transaction recorded on an invalid receipt, as specified in condition 6 below.
6. The following receipts are not valid receipts for the purpose of the Promotion: (a) receipt(s) from non-participating retailers and Excluded Retailers; (b) receipt(s) recording bill payments, lottery ticket and tobacco and tobacco related product purchases; (c) receipts recording layby payments except where a layby is finalised and payment completed during the Promotion Period; (d) receipts recording redemption of gift card purchases, store credit, refunds and exchanges; (e) ATM or EFTPOS receipts; (f) credit card or bank statements; and (g) receipt not meeting qualified spend amounts and (h) receipts that the Promoter has reasonably determined to have been tampered with or have been obtained fraudulently or are a reprint of the original receipts. The same purchase receipt can only be submitted once in the Promotion. The Promoter reserves the right to stamp and/or photocopy each purchase receipt submitted in the Promotion before returning them and to request to see a copy of the receipt should they be deemed a winner.

7. It is a requirement of entry into the Promotion that the entrant agrees that their personal information can be used in accordance with these Terms and Conditions, including for the purposes set out in clause 22.

8. The draw will take place at the entry barrel at Miller Cafe 90 Cartwright Ave Miller NSW 2168 each Friday at 10am for 3 weeks. The barrel will then be emptied to commence the new week. For the avoidance of doubt, week 1 starts 10am on Friday 26 November 2021 – 10am on Friday 3 December 2021; week 2 starts 10.30 am on Friday 3 December 2021 – 10am Friday 10 December 2021 and week 3 starts 10.30am Friday 10 December 2021 – 10am Friday 17 December 2021. Each week 5 winners will be drawn. Each Winner will win 1x \$100 Miller Central Voucher that can be redeemed at any Miller Central retailer in accordance with Section 11. The Promoter reserves the right to draw reserves in case of an invalid entry or invalid entrant. The Promoter reserves the right to request winners to provide proof of identity and/or proof of entry validity in order to claim the prize.

9. The 5 provisional winners each week will be notified by phone and email within 2 business days of the draw. The provisional winner will only be deemed a winner once verified by the Promoter. The winner will have their name and postcode published on the Centre's website and Facebook once verified.

10. The unclaimed prize draw will take place at the same place as the original draw on the Wednesday of the following week's draw. That is, Unclaimed week 1 prizes will be redrawn on Wednesday 8 December at 10am; unclaimed week 2 prizes will be redrawn on Wednesday 15 December 2021 and unclaimed week 3 prizes will be redrawn on Wednesday 22 December 2021 at 10am subject to any directions from a regulatory authority. The winner will be notified by email within 2 business days of the draw by phone and email. The winner will have their name and postcode published on the centre's website.

11. The Prize is subject to the standard terms and conditions of individual product and service providers. The prize must be redeemed at **one participating retailer in one transaction by 4pm Friday 24 December 2021**. The prize, or any unused portion of the prize, are not transferable or exchangeable and cannot be taken as cash. For the avoidance if doubt, If the value of the transaction is under \$100, no change will be given to the participant. If the transaction is over \$100, the participant must pay the outstanding amount at the time of the transaction.

12. At the time of collecting prize, the winners must co-ordinate with Centre Management the date, time and shop at Miller Central they choose to redeem their voucher. Redemption can only be done during office hours **Monday – Friday 9am – 5pm**. A centre management representative will accompany winner to the shop of choice and purchase winner's wish up to the value of \$100 at the appointed time.

13. The voucher must be forfeited at the time of transaction. If for any reason a participant does not take the Prize or an element of the Prize at the time stipulated, then the Prize or that element of the Prize will be forfeited and will not be redeemable for cash. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to:- technical difficulties, unauthorised intervention or fraud, then the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any Entrant; or (b) subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate.

19. The Promoter's decision relating to the Promotion and/or redemption of the prizes is final and no discussions or correspondence with participants or any other person will be entered into.

20. The Promoter reserves the right to vary the terms of, or cancel, this Promotion at any time without liability to any participant or other person, subject to applicable laws.

Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the State and Territories of Australia ("Non-Excludable Guarantees").

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (JEA HOLDINGS (AUST) PTY LTD AFT THE MILLER INVESTMENT TRUST trading as Miller Central including their respective officers, employees and agents) are not responsible for and exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion, including (but not limiting): (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or correspondence that is late, lost, altered, damaged or misdirected (whether received by the Promoter or not) due to any reason beyond the reasonable control of the Promoter; (d) any variation in the prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by an entrant or winner; or (f) use of the prize.
