

**TERMS AND CONDITIONS FOR
FREE PRINTED PHOTO FOR MUM GIFT WITH PURCHASE AT MILLER CENTRAL**

1. Information on how enter the promotion and redeem a free 6x8inch printed photo from Miller Central form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Australian residents. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions.
3. Employees of the Promoter and their immediate families and retailers within Miller Central (the Centre) and the retailers' employees and their immediate families are ineligible.
4. Promotion on Sunday 7 May from 10am – 1pm, or while stocks last (“Promotional Period”).
5. To receive a complimentary 6x8inch printed photo, individuals must complete the following steps during the Promotional Period:
 - a **Spend \$10 or more at any specialty store or \$50 or more at Woolworths or ALDI at Miller Central dated between 1/5/23 – 7/5/23** (“minimum spend”).
 - b) Present their receipt (s) to the photography staff located near the Food Court. The staff member will confirm the amount spent, the purchase date and the retailer where the spend was made and issue one 6x8inch printed photo of the entrant or the entrant’s family.
6. Offer available from 10am- 1pm during the promotional period.
7. Free 6x8inch printed photo are only available whilst stocks last.
8. Subject to the first 100 customers. This quantity is subject to change depending on demand.
9. **Only one (1) free 6x8inch photo is permitted per family during the promotional period regardless of the amount spent.** Additional photos may be available for purchase as determined by Corporate and Event Imaging.
10. Incomplete, indecipherable, or illegible receipts will be deemed invalid.
11. The following receipts are not valid receipts for the purpose of the Promotion: (a) receipt(s) from non-participating retailers and Excluded Retailers; (b) receipt(s) recording bill payments, lottery ticket and tobacco and tobacco related product purchases; (c) receipts recording layby payments except where a layby is finalised and payment completed during the Promotion Period; (d) receipts recording redemption of gift card purchases, store credit, refunds and exchanges; (e) ATM or EFTPOS receipts; (f) credit card or bank statements; and (g) receipt not meeting qualified spend amounts and (h) receipts that the Promoter has reasonably determined to have been tampered with or have been obtained fraudulently or are a reprint of the original receipts. The same purchase receipt can only be submitted once in the Promotion. The Promoter reserves the right to mark and/or photocopy each purchase receipt as used to redeem a gift in the Promotion before returning them.
